4. **“Site”** shall mean the place where the works under the Project are to be carried out and the details of which are provided in this document.
5. **“Bid Security/ Earnest Money”** shall mean the amount to be deposited by the Tenderer with the Tender.
6. **“Bid Validity”** shall mean the period for which the Bids shall remain valid.
7. **“Bidder”** shall mean the party participating in the Tendering process pursuant to and in accordance with the terms of this document.
8. **“Contract Agreement”** shall mean the agreement to be signed between the Successful Tenderer and the competent authority of HITES/ HLL.

## SECTION I

### NOTICE INVITING TENDER

1. HITES invites tender from contractors for the work of **Construction of New blood bag manufacturing facility at Konni, Pathanamthitta for HLL Lifecare Limited.**
2. The work is estimated to cost **Rs. 25.00 Crores.** This estimate however, is given merely as a rough guide.
3. Agreement shall be drawn with the successful tenderer and all the Five volumes of the tender document shall form part of the contract.
4. The time allowed for carrying out the work will be 13 months from the fifteenth day after the date of written orders to commence the work or from the first day of handing over the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
5. The site for the work is available.
6. Tender documents can be downloaded from the HLL web site [www.lifecarehll.com](http://www.lifecarehll.com) or Central Public Procurement Portal and the cost of tender document of Rs. **5250/-** (Rupees Five Thousand two hundred and fifty only) as DD taken in favour of HITES payable at Thiruvananthapuram shall be submitted along with the tender as processing fee of tender documents.
7. Tenders, **which should be placed in sealed envelopes, as prescribed in Para 11 of Section II (Information & Instructions to Tenderers)**, will be **received by the Deputy Vice President (Technical), HITES, Adarsh, TC 6/1718 (1), Vettamukku, Thirumala PO, Thiruvananthapuram** upto 2.00 PM on 29.01.2016. The Technical Bid will be opened by him or his authorized representative in his office the same day at 3.00 PM.
8. Earnest Money of Rs. **35 lakhs** should be placed in a separate sealed cover marked "Earnest Money" shall be submitted along with the tenders in the form of a Demand Draft/ FDR/ Bankers cheque of a scheduled bank issued in favour of **HITES, Thiruvananthapuram**. A part of earnest money is acceptable in the form of bank guarantee also. In such case, Rs. **17.5 lakhs** will have to be deposited as prescribed above and balance of Rs.17.50 lakhs can be accepted in the form of bank Guarantee issued by a scheduled bank.
9. The contractor shall be required to deposit an amount equal to 5% of the tendered value of the work as performance guarantee in the form of an irrevocable guarantee bond of any scheduled bank or State Bank of India in the prescribed form within 20 days of issue of letter of acceptance.
10. The scope of the work is to **construct New blood bag manufacturing facility at Konni, Pathanamthitta for HLL Lifecare Limited.**

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and the nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity, access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender implies that the tenderer has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done, local conditions and other factors having a bearing on the execution of the work.

11. HITES does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.
12. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
13. HITES reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.

The firm or contractor shall not be permitted to tender for work in case his near relative (s) (directly recruited or on deputation in HITES/HLL) is/are posted in any capacity either non-executive or executive employee. The contractor shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relative to any executive employee/ gazetted officer in HITES/HLL or in the Ministry of Health and Family Welfare.

14. No Engineer of Gazetted rank or other Gazetted Officer employed in engineering or administrative duties in an Engineering Department of the Government of India/State Government or PSU's is allowed to work as a contractor for a period of two years after his retirement from Govt. service, without previous permission of the Govt. of India or HITES/HLL in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Govt. of India/State Government or PSU's as aforesaid before submission of the tender or engagement in the contractor's service.
15. The tender for the work shall remain open for acceptance for a period of 120 **days** from the date of opening of financial bid. If any tenderer withdraws his tender before the said period or issue of letter of acceptance/intent, whichever is earlier, or, makes any modifications in the terms and conditions of the tender which are not acceptable to the HITES, then the HITES shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.

16. This Notice Inviting Tender shall form a part of the Contract Document. In accordance with clause 1 of the contract, the letter of acceptance shall be issued in favour of the successful Tenderer/ Contractor. The contract shall be deemed to have come into effect on issue of communication of acceptance of the tender. On such communication of acceptance, the successful Tenderer/Contractor shall, within 20 days from such date, formally sign the agreement consisting of: -

The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, forming part of the tender, and, as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

## SECTION II

### **INFORMATION & INSTRUCTIONS FOR APPLICANTS**

#### **1.0 GENERAL:**

- 1.1 Letter of transmittal and forms for Technical Evaluation are given in Section III.
- 1.2 All information called for in the enclosed forms should be furnished against the relevant columns in the forms. If for any reason, information is furnished on a separate sheet, this fact should be mentioned against the relevant column. Even if no information is to be provided in a column, a "nil" or "no such case" entry should be made in that column. If any particulars/query is not applicable in case of the applicant, it should be stated as "not applicable". The applicants are cautioned that not giving complete information called for in the application forms or not giving it in clear terms or making any change in the prescribed forms or deliberately suppressing the information may result in the applicant being summarily disqualified. Applications made by telegram or telex and those received late will not be entertained.
- 1.3 The application should be neatly type-written in English. The applicant should sign each page of the application.
- 1.4 Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, initialing, dating and rewriting. Pages of the qualification document are numbered. Additional sheets, if any added by the contractor, should also be numbered by him. They should be submitted as a package with signed letter of transmittal.
- 1.5 References, information and certificates from the respective clients certifying suitability, technical know how or capability of the applicant should be signed by an officer not below the rank of Executive Engineer or equivalent.
- 1.6 The applicant may furnish any additional information, which he thinks is necessary to establish his capabilities to successfully complete the envisaged work. He is, however, advised not to furnish superfluous information. No information shall be entertained after submission of pre-qualification document unless it is called for by the Employer.
- 1.7 Any information furnished by the applicant found to be incorrect either immediately or at a later date, would render him liable to be debarred from tendering/taking up of work for HLL Lifecare Limited/ HITES.
- 1.8 Prospective applicants may request clarification regarding the Tender document on before the date specified in the **"SCHEDULE FOR SUBMISSION OF**

**APPLICATION".** Any clarification given by the Employer will be posted in the web sites of HLL. No request for clarification will be considered after.

- 1.9 Joint Venture firms are not allowed to participate in the tender.

## **2.0 METHOD OF APPLICATION:**

- 2.1 If the applicant is an individual, the applicant shall affix his signature above his name type written in full along with his current address.
- 2.2 If the applicant is a proprietary firm, the application shall be signed by the proprietor above his name type written in full along with the full name of his firm and its current address.
- 2.3 If the applicant is a firm in partnership, the application shall be signed by all the partners of the firm above their full type-written names and current addresses or alternatively by a partner holding power of attorney for the firm. In the latter case a certified copy of the power of attorney should accompany the application. In both cases a certified copy of the partnership deed and current address of all the partners of the firm should accompany the application.
- 2.4 If the applicant is a limited company or a corporation, the application shall be signed by a duly authorized person holding power of attorney for signing the application accompanied by a copy of the power of attorney. The applicant should also furnish a copy of the Memorandum of Articles of Association duly attested by a Public Notary.

## **3.0 FINAL DECISION MAKING AUTHORITY**

The employer reserves the right to accept or reject any application and to annul the qualification process and reject all application at any time, without assigning any reason or incurring any liability to the applicants.

## **4.0 PARTICULARS PROVISIONAL**

The particulars of the work given in Section I are provisional. They are liable to change and must be considered only as advance information to assist the applicant.

## **5.0 SITE VISIT**

The applicant is advised to visit the site of work, at his own cost, and examine it and its surroundings by himself, collect all information that he considers necessary for proper assessment of the prospective assignment.

## **6.0 TENDER DOCUMENTS**

- 6.1 The tender documents consisting of the following four parts documents

1. Part-I- Technical Bid
  2. Part-II – General Conditions of Contract
  3. Part-III- Special Conditions of Contract
  4. Part-IV - BOQ and Price Bid
  5. Part-V- Drawings
- 6.2 The tenderer is expected to examine carefully all the contents of the tender documents including instructions, conditions, forms, terms etc. and take them fully into account before submitting the offer. Failure to comply with the requirements as detailed in these documents shall be at the tenderers own risk.

## **7.0 SUBMISSION OF THE TENDER DOCUMENTS**

The tender document shall be submitted in two parts

1. Part- I- Technical Bid
2. Part-II- Price Bid

### **7.1 Part –I Technical Bid shall consisting of the following,**

a. Earnest Money Deposit

Earnest Money Deposit, as detailed in clause 8 of NIT in original, placed in a separate sealed envelope and duly marked "Earnest Money Deposit".

b. Power of Attorney

Attested copy of Power of Attorney (in favour of the authorized signatory of the tenderer) to submit the tender.

c. Signed copies of Technical Bid, General Conditions of Contract & Special conditions of contract, unpriced BOQ & Drawings.

d. Letter of transmittal

The applicant should submit the letter of transmittal attached with this document.

e. Financial information

Applicant should furnish the Annual financial statement for the last five years (in Form "A") & Solvency (in Form "B")

f. Experience in works/ similar works

Applicant should furnish the following:

- A. List of all works of similar class successfully completed during the last seven years (in Form "C").
- B. List of the projects under execution or awarded (in Form "D").
- C. Particulars of completed works and performance of the applicant duly authenticated/certified by an officer not below the rank of Executive Engineer or equivalent should be furnished separately for each work completed or in progress (in Form "E").

g. Organization information

Applicant is required to submit the following information in respect of his organization (in Forms "F" & "G").

- A. Name & Postal Address, Telephone & Fax Number etc.
- B. Copies of original documents defining the legal status, place or Registration and principal places of business:
- C. Names & Title of Directors and Officers to be concerned with the work, with designation of individuals authorized to act for the organization.
- D. Information on any litigation in which the applicant was involved during the last five years, including any current litigation.
- E. Authorization for employer to seek detailed references.
- F. Number of Technical & Administrative Employees in parent company, subsidiary company and how these would be involved in this work (in Form "G").

h. Construction plant & equipment

Applicant should furnish the list of construction plant and equipment including steel shuttering, centering and scaffolding likely to be used in carrying out the work. (in Form "H"). Details of any other plant & equipment required for the work (not included in Form F and available with the applicant may also be indicated.

**7.2 Part -II Price Bid shall consisting of the following**

- a. Completed Price bid

**8.0 ELIGIBILITY CRITERIA FOR QUALIFICATION**

The tenderers who meet the following criteria only shall be considered for price bid opening.

**I. Eligibility criteria for Empanelled Contractors (Category IV – Class A (CW) to E (CW)**

8.1 The contractors shall be empanelled in Category IV – Class A (CW) to E (CW).

8.2 Those who had done work/doing work in HLL/ HITES shall produce completion/ progress certificate from the HLL/ HITES Engineer in charge not below the rank of Project manager. The contractor shall be considered for further evaluation only if the performance of the bidder for the work is rated as 'good'. This is mandatory.

8.3 The bidder shall submit the credentials of the electrical subcontractors proposed to be deployed for this project such as experience in executing similar works of similar value in the last three years. Certificate of satisfactory completion/ commissioning and working of the plant with date of completion, value as per final bill paid duly certified by authorized official not below the rank of executive engineer/ Project Manager to be enclosed. The electrical subcontractor should have 'A' class Electrical License issued by Kerala State Electrical Licensing Board.

8.4 The bidding capacity of the applicant should be equal to or more than the cost of the work. The bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = A * N * 2 - B$$

Where,

A = Maximum value of construction works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of work for which Bids have been invited.

B = Value of existing commitments and ongoing works to be completed during the period of completion of work for which Bids have been invited.

**8.5 The bidder shall submit the construction schedule for the work (minimum no. of activities in the schedule shall be 30) including proposed average manpower deployment per month.**

For enlisted parties, only the eligibility criteria are separate as above. They shall abide all other conditions in the tender including submission of EMD and tender cost.

## **II. Eligibility Criteria for Non Empanelled contractors**

8.1 (i) The applicant shall have experience of having successfully completed works during the last 7 years ending last day of the month previous to the one in which applications are invited:

Three similar completed works each costing not less than 40% of the estimated cost of work.

Or

Two similar completed works, each costing not less than 60% of the estimated cost of work.

Or

One similar completed work of aggregate cost not less than 80% of the estimated cost of work.

And

(ii) One Completed work of any nature (either part of (i) or a separate one) costing not less than 40% of the estimated cost of work with some Central Government Department/ State Government Department/ Central Autonomous Body/ Central Public Sector undertaking.

'Cost of work' shall mean gross value of the completed work including the cost of materials supplied by the Employer/Client, but excluding those supplied free of cost. This should be certified by an officer not below the rank of Executive Engineer/ Project Manager or equivalent.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

**8.2 Those who had done work/doing work in HLL/HITES shall produce completion/ progress certificate from the HLL/ HITES Engineer in charge not below the rank of Project manager. The contractor shall be considered for further evaluation only if the performance of the bidder for the work is rated as 'good'. This is mandatory.**

8.3 The bidder shall submit the credentials of the electrical subcontractors proposed to be deployed for this project such as experience in executing similar works of similar value in the last three years. Certificate of satisfactory completion/ commissioning and working of the plant with date of completion, value as per final bill paid duly certified by authorized official not below the rank of executive engineer/ Project Manager to be enclosed. The electrical subcontractor should have 'A' class Electrical License issued by Kerala State Electrical Licensing Board.

8.4 The average annual financial turnover on construction works shall be atleast 100% of the estimated cost of work during the immediate last 3 consecutive financial years ending 31<sup>st</sup> March 2015. The documentary evidence duly audited and certified by a Chartered Accountant must be furnished along with the application. The year in which no turnover is shown would also be considered for working out the average.

8.5 The bidder should not have incurred any loss in more than two years during the last five years ending 31<sup>st</sup> March 2015.

8.6 The bidder should have a solvency of 40% of the estimated cost of work in the current financial year and it should be certified by his bankers.

8.7 The bidding capacity of the applicant should be equal to or more than the cost of the work. The bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = A \times N^2 - B$$

Where,

A = Maximum value of construction works executed in any one year during the last five years taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of work for which Bids have been invited.

B = Value of existing commitments and ongoing works to be completed during the period of completion of work for which Bids have been invited.

8.8 The applicant should own construction equipment as per list required for the proper and timely execution of the work. Else, he should certify that he would be able to manage the equipment by hiring etc., and submit the list of firms from whom he proposes to hire.

**8.9 The bidder shall submit the construction schedule for the work (minimum no. of activities in the schedule shall be 30) including proposed average manpower deployment per month.**

8.10 The applicant should have sufficient number of Technical and Administrative employees for the proper execution of the contract. The applicant should submit a list of these employees stating clearly how these would be involved in this work.

8.11 Joint venture/ consortium are not permitted.

8.12 The applicant's performance for each work completed in the last 5 years and in hand should be certified by an officer not below the rank of Executive Engineer or equivalent and should be furnished along with the application.

## **9.0 EVALUATION OF TECHNICAL BID**

9.1 The applicants will be evaluated in the following manner:

- i. The initial criteria prescribed in para 8.1 to 8.10 above in respect of experience of similar class of works completed, bidding capacity and financial turn over, construction schedule etc. will first be scrutinized and the applicant's eligibility for qualification for the work be determined.
- ii. The applicants qualifying the initial criteria as set out in para 8.1 to 8.10 above will be evaluated for following criteria by scoring method on the basis of details furnished by them.

A. Financial strength (Form 'A' & 'B')	Maximum 20 Marks
B. Experience in similar nature of work during the last five years (Form 'C')	Maximum 20 Marks
C. Performance of works (Form 'E') (TOR, 20 marks & Performance, 15 marks)	Maximum 30 Marks
D. Personnel and Establishment (Forms "F" & "G")	Maximum 10 Marks
E. Plant & Equipment (Form 'H')	Maximum 10 Marks
F. Construction schedule	Maximum 10 Marks
Total	100 Marks

**To become eligible for short listing the bidder for financial bid opening, the applicant must secure at least fifty percent marks in each criteria and sixty percent marks in aggregate.**

HITES, however, reserves the right to restrict the list of qualified bidders to any number deemed suitable by it.

- b. Even though an applicant may satisfy the above requirements, he would be liable for disqualification if he has:
