FOR OFFICIAL USE ON CONTRACT BASIS

- 1) The tenderer must be the owner of vehicles. In case of Firm / Company, the vehicle can be owned by the Firm/Company. The vehicle should be registered on or after 1st January 2016. Copy of the RC book to be enclosed along with the tender to prove the ownership and year of Registration. In the case RC book is not available at the time of tender opening, and then the same shall be submitted within 30 days from the tender opening date. The vehicle should be diesel / petrol variant with functional A/C system. The vehicles provided should be roadworthy, in good condition, and should have valid registration, road permit, records of having paid road tax and insurance, to carry out the passenger transportation. The copy of RC Book, Road Tax and Insurance paid Certificate, Fitness Certificate, Taxi Permit and Pollution Certificate duly self-attested shall be submitted along with Tender document for the offered vehicles.
- 2) If the contractor is a firm / company, GST registration shall be produced if applicable.

- 8) The rates quoted shall include wages to the driver, cost of oil, fuel, taxes, insurance, and service charges. The Contractor shall solely be responsible for compliance of statutory and non-statutory requirements involved in providing the vehicle on monthly rental.
- 9) In case of any accident the contractor will be solely liable and HLL Lifecare Limited will not have any liability for the damages or compensation.
- 10) The contractor shall bear the cost of all the maintenance work of the vehicle provided.
