In case of bunch bids, the category of primary product having highest value should meet this criterion.
4. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is

automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 5. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. The sequencing workflow should allow fully automated, walk-away operation, without user intervention and support unattended operation.

The system should offer flexible scalability from Minimum 1.5 Gb or maximum 30 GB or more in a single run to support a broad range of applications, including metagenomic sequencing, Targeted gene panels, oncology panels, HLA typing, sRNA sequence, de-novo sequencing and re-sequencing of microbes, complete de-novo sequencing and re-sequencing of higher eukaryotes (microbial, plants, and environmental samples).
9. System should offer On-Board Bio-IT platform & Pipeline for whole & targeted resequencing, transcriptome expression and targeted sequencing at least till secondary analysis.
10. The sequencing chemistry should be robust and globally proven, demonstrated with over 10000 peer-reviewed publications.
11. System should be able to sequence multiple samples simultaneously to use barcodes for sample multiplexing, a Maximum of 96.
12. System should have inbuilt hardware for ultra-rapid secondary analysis for various genomic analysis solutions, including BCL conversion, mapping, alignment, sorting, duplicate marking, and variant calling.
13. Complete installation and in-house application training to be provided by the vendor at consignee location. 05 Years comprehensive warranty from the date of installation. CMC for next 5 years must be quoted on annual basis after completion of warranty period.
14. The range of data generation should be minimum 5 Million – 100 Million cluster in single end reads.
15. The sequencing flow cell/chip should be easy to load with simple pipetting without any ancillary instrument support.
16. System should not have any wash steps the flow cell/chip cartridge should be independent use and throw, now complicated steps to be involved.
17. The flow cell /chip should be independent to load individually without any reagent wastage and loss to the institute.
18. The reagents/Consumables should come with minimum guarantee of expiry date between 3 months to 1 year. All the reagents/ consumables required should be quoted and must be freezed for 3 years from the date of award of contract.
19. Sequencing reagents/Cartridges /Flow cells should not be temperature sensitive when shipped or stored in room temperature. The reagents should be stable at room temperature, eliminating the need for a cold chain and reducing wait times for sample preparation/No Freeze thaw cycle for sequencing reagents.

The sequencing chemistry should be as robust as Sequencing by synthesis or with similar technology with reversible terminators and will mimic natural biological chemistry with simultaneous addition of all four bases in the sequencing reaction for competitive addition to the DNA template.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
