1. Warranty should be for minimum 2 years from the date of acceptance of Non Invasive Cardiac output Monitor and the Warranty has to be given in the name of client.

1.1	Parameters required - ECG, Respiration, NIBP, SpO2, Temperature, and Non Invasive Cardiac Output
1.2	Should have eight digital and waveforms/traces display
1.3	Should have minimum 12 inches multicoloured LCD display screen.
1.4	Should have the capability for storage of patient data and printing of patient reports.
1.5	Monitor should have audible and visual alarms capability. .
1.6	Should have automatic arrhythmia detection & alarm for standard and lethal arrhythmia.
1.7	Should have trend of at least 24 hours.
1.8	The monitors should have battery back up of minimum 2 hrs
1.9	Power input to be 220-240VAC, 50Hz fitted with Indian plug
1.10	Monitors should be supplied with wallmount, swivel type stands of high quality
2	System Configuration Accessories, spares and consumables for Bedside monitor
2.1	ECG/Resp :5 Lead ECG Cable with clip- 1 sets per monitor
2.2	NIBP:Adult cuff- with cable -01 nos. per monitor
2.3	SpO2:Adult SpO2 sensor with cable- one nos per monitor
